- Electronic bids must be submitted to the office Road Infrastructure Development Office, Dang through PPMO website www.bolpatra.gov.np/egp on or before **12.00 Hrs. on 26 April, 2026**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **13.00 Hrs. on 26 April, 2026** at the **Road Infrastructure Development Office, Dang**. Bids must be valid for a period of **45 days** i.e. **10 June, 2026** and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of following, which shall be valid for 30 days beyond the validity period of the bid (i.e. **10 July, 2026**).
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Other mandatory information shall be as per PPA & PPR (Amended).
